HEIFER VALIDATION:

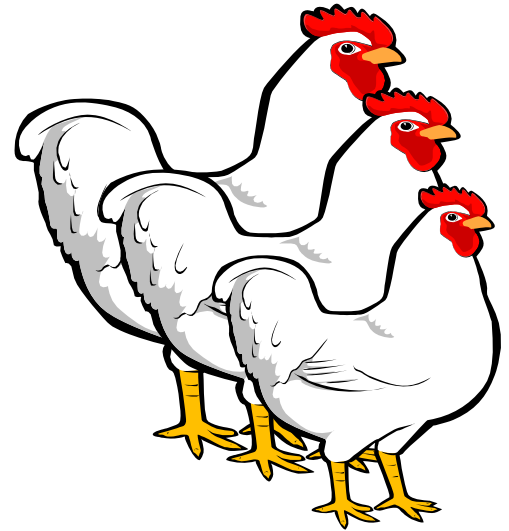
Heifer validation will be on Wednesday, October 21, 2015, from 4:00—7:00 p.m. at the Expo Center. Cost \$12.00 per heifer.

Birds will be at the County Extension Office on December 16, 2015, - 3:30—5:30 p.m.

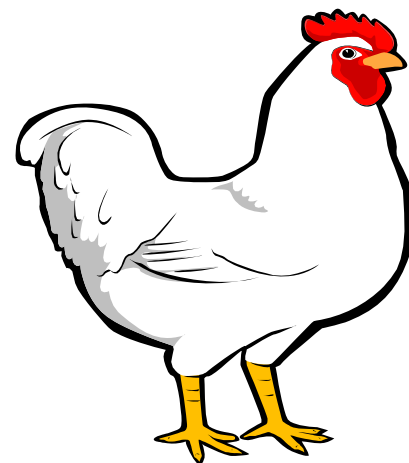
